GENERAL DISPOSITIONS

Art. 1

2020 University Paralympic Games Entry Package is composed by:

- 2020 University Paralympic Games Regulation
- Sport Specific regulations
- Attached files

PURPOSES

Art.2

2020 University Paralympic Games main objective is to stimulate sport activities for college students with visual, physical and intellectual impairments, enrolled in Institute of Higher Education (IHE), promoting mobilization along sport.

JUSTIFICATION

Art. 3

Youth education through university sports programs aims at the spread and reinforcement of citizenship values and Paralympics ideals. Those are directed to the accomplishment of a more pacific world, free of all kinds of discrimination, full of human diversity understanding and mutual comprehension, fraternity, solidarity and fair-play willingness. Through sports activities, university youth build up their values and concepts, socialize and live their own realities.

OBJECTIVES

Art. 4

2020 University Paralympic Games objectives are:

- Stimulate university students, from across the globe, with physical, visual and intellectual impairments, to sports activities;
- To occasion a grow environment to the Paralympic athletes in evidence;





- Make of sports activities an integration and cultural interchange factor for university students;
- Provide and stimulate continuity to the Paralympic sport practice to university students across the nation.
- Contribute to full development to university students as a social, autonomous, democratic being, stimulating full exercise of citizenship trough sports.

EXECUTION

Art. 5

2020 University Paralympic Games will take place at São Paulo – SP, between July 23rd and 26th and enrolled university students will be able to enter.

Art. 6

2020 University Paralympic Games are an execution from Comitê Paralímpico Brasileiro – CPB, Confederação Brasileira do Desporto Universitário – CBDU and Ministério da Cidadania through Secretaria Especial do Esporte, with support form Concelho Federal de Educação Física (CONFEF).

RESPONSABILITIES

Art. 7

CPB's responsibilities are:

- Indicate 2020 University Paralympic Games' head director;
- Elaborate 2020 University Paralympic Game's entry book and, approve along CPB's sport coordinators and involved sports confederations, sport specifics rule books, as well as technical directives and their executions;
- Deliberate upon Institutes of Higher Education, helping them to achieve a bigger entry to **2020 University Paralympic Games** competitions;
- Inspect and approve along the inspection commission, the venues to be utilized by the games;
- Formulate a technical and operational resources plan intended to the competitions;
- Request from Brazilian Sports Confederations and Associations involved in the games, indication of their representatives to compose a Technical Coordination Board, as well as the Refereeing and classification teams, following established criteria;
- Describe, along Brazilian Sports Confederations and Associations involved, technical material for each involved sport;







- Formulate sports program, results debug, and technical and administrative official reports;
- Arrange logging, food catering and internal transportation logistic in association with the Institutes of Higher Education involved and the host city;
- Supervise permanently the Event Organization project, promoting actions and opening ceremony planning executions.
- Be responsible for payment of the following expenses with resources from "Angleo/Piva" law and specific agreements:
 - Logging and food catering of Human Resources (CPB and other crews) involved in the event;
 - Awarding (medals);
 - Event promotional materials (Printed materials, t-shirts, banners, backdrops, etc.).
 - Refereeing and support crew services;
 - Water and ice consumption during the games;
 - Other services needed to the event installment.
- Be responsible for the accountability reports submission in legal term;
- Approve participant entries to the **2020 University Paralympic Games** sent by the Institutes of Higher Education, or directly by the university student, since fulfilling the legal requirements.

First amendment: The logging, food catering and internal transportation for the students enrolled in the games will be provided form 12:00 pm of July 23rd to 12:00 pm of July 26th.

Second amendment: CPB will not take responsibilities for logging, food catering and internal transportation outside the period established on the amendment above.

Art. 8

Ministério da Cidadania por meio da Secretaria Especial do Esporte e a Confederação Brasileira do Desporto Universitário – CBDU, caberão:

- Support the event realization contacting other public and private entities responsible for the venues to be utilized;
- Stimulate the participation of the Institutes of Higher Education, public or private, with enrolled students with disabilities (physical, visual or intellectual), using advertising on their reach;
- Promote and instigate involvement from state authorities and hosting state on making feasible the usage of physical structures and material needed for the sports competition.











COMISSION

Art. 9

The organizational structure of **2020 University Paralympic Games** will be composed by the commissions:

- Honor Committee;
- Organizing Committee;
- Special Disciplinary Commission.

Art. 10

The **2020 University Paralympic Games** Honor Committee will be composed by CPB president, Secretaria Especial do Esporte legal representative, CBDU president and the local Government representative.

Art. 11

The **2020 University Paralympic Games** Organizing Committee will be composed by CPB representatives in accordance with CBDU.

Art. 12

The **2020 University Paralympic Games** Special Disciplinary Commission will be nominated and will execute their attributions in accordance to the Paralympic Disciplinary Commission Court. Available at: http://www.cpb.org.br/conheca-o-cpb/legislacao-esportiva.

COMPETITIONS

Art. 13

2020 University Paralympic Games will happen at the venues determined by the Technical Management, considering disqualified by no show, the student not ready to play in the venue and time established to the competition.

Art. 14

Pleads about problems with food catering, bad weather, traffic or placement of the competition venues, won't be accepted.



Art. 15

Any competition suspended or transferred by the Organizing Committee for any reason, will take place inside of 12 (twelve) hours after the original programmed time, since all the delay reasons have been eliminated. Results obtained until the competition stoppage will remain.

Art. 16

All sports will only be available and have their results validated with at least 3 (tree) athletes' entries, respecting the specific sport regulation in gender division and functional class.

First Amendment: For Athletics and Swimming events, there won't be class gathering. That means, every event/class offered with enrolled athletes will be awarded, independently of the number of enrolled athletes.

PARTICIPATION AND SPORTS

Art. 17

2020 University Paralympic Games entry is open for male and female university students with disabilities (physical, visual or intellectual) with the minimum age of 17 years old, with no maximum age, according to the sports described in the first amendment of this article, and properly enrolled in an Institute of Higher Education.

OBS: Non-Brazilian Athletes can entry the competition since verified university enrollment in 2020, done by letterheaded proof of registration signed by the principal, and a valid passport.

An entry fee of U\$ 80,00 (eighty US Dollars) will be charged to non-Brazilians student athletes to participate on **2020 University Paralympic Games**. It will cover internal transportation, food catering and logging.

First amendment: The Sports competitions in **2020 University Paralympic Games** will be:

- Athletics;
 - Boccia
- Judo

- Swimming
- Table Tennis

Second amendment: Each student can only entry in one of the sports above mentioned.

PARTICIPATING CONDITIONS

Art. 18

Any student with disabilities, rightfully enrolled in an Institute of Higher Education, has the right of participating in **2020 University Paralympic Games**.

Art. 19

The **2020 University Paralympic Games'** credential, together with a valid identification with picture (passport for foreigners) will give participation conditions to, students, coaches, and principals. The usage is mandatory.

First amendment: No other document will give participation conditions to games, events, weighting and combat, besides the mentioned in the main section of the article.

Second amendment: A referring team representative will proceed the credential check in every participation of student athlete, technical commissions and principals.

Third amendment: If, by any reason, a principal should take a coach or physical conditioner position, a professional council document should be provided. On the contrary the participation will be denied.

Fourth amendment: In case of loss, a duplicate should be provided at the Control and Credential Coordination. The student or his representative will fill a formulary and present the identification document.

Art. 20

Whenever it is possible, for collective sports, there should be a coach. If there is no coach available, the team should be supervised by the sport technical coordinator, which the team should treat respectfully.

First amendment: When, during the game, a coach gets disqualified, expelled or needs medical treatment, the sport specific rule should be applied.





FUNCTIONAL, VISUAL AND INTELLECTUAL CLASSIFICATION

Art. 21

The Organization Committee will provide a classification panel to provide all student athletes a classification recognized by CPB and by national and international confederations. Every physically impaired student athlete should present themselves in the sport appropriated suit to participate in the classification process.

First paragraph: Visually impaired student athletes should send to CPB to **classificacao@cpb.org.br**, along with the entry request, the CPB's formulary (attached file III) attested by an ophthalmologist. Not sending the formulary will automatically disqualify the entry.

Second Paragraph: Intellectually impaired student athletes should follow mandatorily the Confederação Brasileira de Desporto de Deficientes Intelectuais – CBDI classification criteria. All documents should be sent to CBDI until June 5th, 2020.

Following the documents that should be sent:

- 1. Psychological report with the athlete history. IQ tests Wisc-IV (until 16 years of age) and WASI short scale (after 17) with scores and tables, describing adaptative behavior.
- 2. Medical diagnosis, with CID -10 F (70 -79)
- 3. Athlete record in: www.abdem.com.br, ID and a 3x4 picture.
- 4.

If the above-mentioned criteria are not followed, the student athlete will not participate in **2020 University Paralympic Games**.

Third Paragraph: All student athletes designated with a non-eligible classification in **2020 University Paralympic Games** should withdraw from the competition as soon as the outcome is published. All expenses responsibilities will come to the Institute of Higher Education the athlete is enrolled to.

OBS: Saturday June 25th, Athletics and Swimming will only have events during the morning.

ENTRY

Art.23

2020 University Paralympic Games entry is a responsibility of the participants or the Institute of Higher Education.

First Paragraph: If the Institute of Higher Education Institute has 3 (three) or more student athletes' entries it will have the right to a Head of Delegation, a coach, a staff, a journalist, and a medical staff entry.



Second Paragraph: IHE shall be allowed to entry a staff member for each boccia Student Athlete, Athletics Student Athlete from classes T11, T31, T32, T51, T52, RR1, RR2 and RR3, and Swimming Student Athletes from classes S1, S2 S3, S4, S11. Wheelchair Basketball team shall entry a Coach and an assistant coach.

Art.24

To enter, the Institute of Higher Education or the Student Athlete, should follow the procedures listed below:

- a) Access the Participant Entry Questionnaire at CPB's web site (<u>http://cadastro.cpb.org.br/inscricao-web/</u>) available after April 6th, 2020;
- b) Fill and send the mentioned questionnaire (<u>http://cadastro.cpb.org.br/inscricao-web/</u>) until May 29th, 2020;
- c) Hand in, upon arrival, at **2020 University Paralympic Games** General Secretary, the forms listed below, filled in accordance with the Entry Questionnaire:

c.1) **Attachment I** – Individual Student Athlete Form, with signatures from the participant, legal guardian for the student, in case the student is under 18 y.o. and the physician; Should be handed in in the moment of accreditation altogether with **Attachment I**, a letterheaded declaration of enrollment form the Institute of Higher Education.

c.2) **Attachment II** – Individual Entry for all Staff (Head of Delegation, Coaches, Staffs, Journalists and medical staff); <u>In this case the IHE should have 3 or more student athletes in the competition.</u>

c.3) Attachment IV – Notarized Logging Authorization for those under 18 y.o.

c.4) Every Student Athletes under 18 y.o. need a travel authorization, in accordance with a resolution from Agência Nacional de Aviação Cívil, to present at the airport.

First Paragraph: All withdraw and substitutions should be requested only and exclusively by email (<u>paralimpiadas.universitarias.2019@cpb.org.br</u>), only accepted until June 10th, 2020. Every substitution should respect gender and sport.

Obs: In case a withdraw is not communicated by the student athlete until, June 10th,2020, his entry for the next year will be automatically blocked.

Second Paragraph: The **Attachment I** form should be signed and stamped by a physician certificating the Student Athlete health conditions for **2020 University Paralympic Games**.

d) The participant or the Institute of Higher Education should present themselves to the **2020 University Paralympic Games** General Secretary from 12 pm to 20 pm of July 23rd, 2020, bringing every described item on the main section of this article, as well as the originals documents:

d.1) Valid Identification Document with pictures of the participants;

d.2) Professional Council document of coaches and physical conditioners, or a proof of qualification, for foreigners' professionals;

d.3) Professional Council document of physicians and physiotherapists, or a proof of qualification, for foreigners professionals;

d.4) It will be mandatory to all participants to provide via email a picture of the face in white background to compose the credential tag.

- e) The Institute of Higher Education that brings any component outside of the forms from Attachment I and Attachement II, or irregularly entered, will pay for their expenses;
- f) The component in terms of item "e" from this present article, will **NOT** be able to respond, represent or participate in **2020 University Paralympic Games**.
- g) No university student will be able to participate without their name in the entry list;
- h) The Student Athlete will only participate in the events of 2020 University
 Paralympic Games with the presentation of his credentials before the event.

Fourth Paragraph: The organizing committee have the power to request others documents not listed with the objective to clarify doubts.

COMPETITION PROCESS

Art. 25

2020 University Paralympic Games' competition process will respect the determinations of IPC's (International Paralympic Committee), the Event Regulation and the Sport Specific Regulation.





TECHNICAL CONGRESS

Art.26

All Technical Congress will happen on July 23rd, 2020.

Obs: There may be changes in time and place for technical congress without previous warning

Art. 27

The Technical Congress will be directed by the Specific Sport Technical Coordination.

Art. 28

During the Technical Congress only one Student Athlete or IHE representative will have the voice right and vote. IHE representative could be a coach or a director.

AWARDS

Art. 29

Awarding will be defined according to each Specific Sport Regulation.

Art. 30

Every sport event award ceremony will happen right after each event or competition. The General Champion Award will be done at the end of all competitions.







UNIFORMS

Art. 31

Each Student Athlete should present himself at the competition venue in proper uniform, accordingly to the specific sport rules.

Art. 32

Confection and maintenance of group uniforms and representatives is a duty of Institutes of Higher Education or individually entered Student Athletes. During individual events and Opening Ceremony, the student can use the IHE uniform.

Art. 33

Sponsor's logos can be used in the uniform confection, if free of politics, philosophical, and religious propaganda, nor allusion to alcohol, tabaco, and addition inductive products or disrespectful of human rights.

REPORTS

Art. 34

Every communication will be publicized trough **2020 University Paralympic Games'** report in electronic media (available at www.cpb.org.br and email addresses indicated by the IHE at the main secretary) in official report. Because of environmental responsibilities, printed official report won't be handed out.

TEAM COMPOSITION

Art. 35

The Institute of Higher Education with more than 3 (three) Student Athletes team, should be composed by a representative, coach, staff, journalist and physician, respecting numbers and directives that follows:

OBS: The PRESS coat, gibing access to all venues, will only be handed to the registered Journalist at entry.

- To every 3 athletes for IHE, another coach will be allowed to entry.
- A guide-runners entry will only be allowed for Student Athletes classified in T11 and T12 for Athletics.







- A tapper entry will only be allowed for Student Athletes classified in S11 for Swimming.
- Every Boccia Student Athlete has a right for a Boccia staff entry.
- For WC Basketball 3x3 teams a Coach and an assistant coach will have entry available.
- The WC Basketball 3x3 could be formed by component of different IHE, if they are from the same State. Local Federations of Confederação Brasileira de Basquete em Cadeira de Rodas – CBC, will support the team composition that will represent the State.
- Each State can only entry one WC Basketball team.
- If the **2020 University Paralympic Games** Organization receives more than one WC Basketball team entry, the first received will prevail.

First Paragraph: It is an IHE Representative and/or Legal Representative duty:

- Officially represent their IHE to the **2020 University Paralympic Games** Organizing Committee;
- Present a valid Identification Document with picture to the accreditation, in order to receive his credential;
- Supervise and be responsible for every IHE member behavioir in and out **2020** University Paralympic Games venues;
- Preserve, along with the IHE team the competition venues, logging areas, food catering and transportation vehicles;
- Comply and make every IHE member compliant of the **2020 University Paralympic Games** regulations;
- Assure the intellectual and physical health of the participants;
- Be responsible for age verification of all IHE's Student Athletes;
- Be responsible for proof of enrollment of all HIS's Student Athletes;

Second Paragraph: Every IHE's participants will be under the representative responsibilities or to whom designated by him. In case there is no representative, the IHE will be advised of any occurrence by email.

Third Paragraph: It is Press duty:

- Cover his IHE's participation during the event, sending content to be published by state press;
- Hand in to the IHE representative a clipping of published content of 2020
 University Paralympic Games in the state, so it can get to CPB.

Fourth Paragraph: It is a Student Athlete duty:

- Respect the Regulations, Directors and decisions taken;
- Present themselves, if requested, a valid Identification Document or Passport to Credential Control to receive their **2020 University Paralympic Games** credential;
- Damaged and adulterated documents, protocols and other documents to receive their **2020 University Paralympic Games** credential;

Fifth Paragraph: It is a Coach duty:

- Be with the team during every programmed game or event, and also out of the competition venues;
- Hand in, if requested, a valid Identification Document of the Professional Council to receive the **2020 University Paralympic Games** credential;
- Watch over discipline, fair-play and rule compliance.

Art.36

Illegal exercise of profession and professional council document validation will be checked by the Professional Council. The professional under illegal exercise could be penalized by law.

Art. 37

To any component that would need to leave **2020 University Paralympic Games** early, by any reason, the IHE representative should write to Organizing Committee;

Single Paragraph: After leaving, the Organizing Committee won't be responsible for internal transportation, food catering, logging or medical care.

ASSINMENTS OF RIGHTS

Art. 38

The **2020 University Paralympic Games** participants, through adhesion of this regulation, assured by the filling of entry term or participation by itself, authorize, in universal disposition, free of charge, irrevocable and irretrievable, Comitê Paralímpico Brasileiro -CPB, or third parts by this authorized, to take pictures, capture and fix you image and voice during all the **2020 University Paralympic Games** realization period, during the competitions, warmups, training, logging, transportation or meal time, in any existing media or those to be created, utilizing it as his own exclusive criteria, at any time, in Brazil and/or outside of the Country, in unlimited amount of time, and also fixing it to any cinematographic films, CD ROM, CD-I, home video, DAT (Digital Audio Tape), DVD (Digital Video Disc) and CG supports in general, or save it to database, being also able to disseminate, broadcast, show and reshow them through screenplay in collective frequency rooms, or public places, through television of any kind, internet, satellite, radio, books, journals, magazines, land or mobile telephone lines, or any other way,

being COB able to, also, transfer the rights now acquired to third parts, free of charge or burdensomely.

First Paragraph: CPB, in the same terms above described, is expressly authorized to use the brands, insignias and emblems of all **2020 University Paralympic Games** participants.

Second Paragraph: It is stated, from now, that the usage of the acquired rights, by CPB and authorized third parts, will be valuing the sports, the Student Athletes and the Event.

MEDICAL CARE

Art. 39

The **2020 University Paralympic Games'** Medical Direction will indicate the physicians to participants' emergency medical care during the competition length, in the event venues and hotels.

Single Paragraph: In the case of a participant removal, because of medical reason, a team member (physician or director) should escort him, during all procedures. In case the participant is alone, he will be escorted by an Organizing Committee's medical staff.

Art. 40

The Organization won't be responsible for the medical treatment continuity for any accidents to **2020 University Paralympic Games** participants before, during or after the competitions.

Art. 41

The transportation to the hospital will be done by an emergency crew form **2020 University Paralympic Games'** Organizing Committee, and the patient will be referred to a public hospital from the host city.

SANCTIONS

Art. 42

All **2020 University Paralympic Games** participants are subjected to the following disciplinary sanctions:

- Verbal Warning;
- Written censure;
- Suspension;
- 2020 University Paralympic Games' Exclusion;



First Paragraph: The disciplinary sanctions will be applied to Paralympic Disciplinary Court's Disciplinary Commission criteria only, in the terms of this regulation and Brazilian Sports Justice Code.

Second Paragraph: Those disciplinary sanctions will automatically come into force as soon as received, by the jurisdicted, written, the Paralympic Disciplinary Court's Disciplinary Commission decision and should be immediately reported to the IHE representatives and published in the Official Report to knowledge and fulfillment.

Third Paragraph: Exclusion because of undisciplined act (aggression and moral offenses) from athletes, coaches, staff or directors, as well as fanbase fight, or fanbase and event staff, or to the opposite team or refereeing team, may refer to sanctions previewed in Article 42.

Art. 43

The IHE Representative will be responsible for every transgression act and every damage caused to third parts or to the competition venue, from the team or the fanbase, from the entry act until the end of **2020 University Paralympic Games.**

Single Paragraph: In case of material damage to the venues, logging areas, and food catering, as well as to the transportation vehicles, the IHE should compensate the Organizing Committee in the next 24 hour after receiving the written warning, under sentence to be excluded from future competitions organized by CPB, CBDU and Ministério dos Esportes, besides others measures may be taken.

APPEAL

Art. 44

In the case of any team representative apply an appeal against another team, refereeing team, classification result or to the competition direction, because of possible transgression of regulation, this appeal should be handed in to their respective sport coordinator, written, in the period of 60 minutes after the result of event or game, and classification, and not more than 30 minutes after official pronunciation of results and classification, so it can pe sent to the Disciplinary Commission, upon payment of R\$200,00 (two hundred reais). If the appeal should be deferred, there will be a restitution of the payment.

Single Paragraph: The IHE that present unreasonable appeals, insulting, or unfunded critiques to the event organization, may be disqualified and sanctioned by the Disciplinary Commission with suspension or exclusion from the games.

Art. 45

The IHE or participant that, without previous authorization from the Organizing Committee, leave the competition before his participation comes to an end, will be

prohibited to participate in next competition of the same nature, and should pay back to CPB the expenses from use of logging and food catering.

GENERAL ARRANGEMENTS

Art. 46

2020 University Paralympic Games' participants should acknowledge the this Genal Regulation and Brazilian Sports Justice Code, being subjected to the arrangements and penalties they could emanate.

Art. 47

Sideways to the competitions and whenever possible, debates, courses and lectures should be provided by CPB.

Art. 48

Cases not taken into consideration by this document will be handled by the Organizing Committee.





ATHLETICS SPECIFIC REGULATION

Art.1

The **2020 University Paralympic Games'** Athletics competition will be in accordance with the World Para Athletics – WPA rules, and modifications previewed in this regulation

Art.2

2020 University Paralympic Games' Athletics competitions entry is open for Student Athletes of both genders, with physical, intellectual and visual impairments.

Art.3

After confirmation of events, at technical congress, the Student Athlete should participate of all events entered. In case of injury, the Athlete should present himself to the Medical Delegate to be examined and, if the case, have a medical leave to the event. This document should be handed in at the call room until last call for the event. By not following this procedure, the student athlete will automatically be declassified and the IHE will lose 5 (five) points on the final score for each absence on the event, which will be identified as DNS (did not started). The Student Athlete may keep competing in following events.

Art.4

For the Athletics Competition, Student Athletes will be classified in accordance with CPB/WPA's Functional, Ophthalmological and Intellectual Classification;

Art.5

Implements needed for field events (F) will be the same utilized during CPB's national competition – Circuito Brasil LOTERIAS CAIXA 2020.

Art.6

The events to be realized are:

For field events, Student Athletes can use their own equipment, subjected to inspection by the refereeing team.



Medals will be awarded to the first 3 (three) Student Athletes classified in each event.

Art.15

The distance between the board and the falling sector in Long Jump will be of 1 meter for Male and Female events.

Art.16

Cases not taken into consideration in this regulation, will be resolved by CPB technical board or their representative.





SWIMMING SPECIFIC REGULATION

Art.1

2020 University Paralympic Games' Swimming competition will follow the World Para Swimming rules and some adaptations described in this regulation.

Art.2

2020 University Paralympic Games' Swimming competition is open for Student Athletes of both genders, with physical, visual or intellectual impairments with functional classification accordingly with World Para Swimming International Classification System.

Art.3

Swimming competition will take place on a 50 meters length swimming pool, with eight lanes.

Art.4

The events will be contested in finals, directly. Athletes will be distributed in lanes by their time. Awarding will be done by classification separately.

Art.5

There won't be class aggrupation, that means, evert event with at least one Student Athlete entry will be awarded.

Art.6

Medals will be awarded to the first 3 (three) Student Athletes classified in their events.

Art.7

The Swimming Event Program will be contested in two days, as listed below:

DAY 1 – Warmup: 2 pm Events starts at: 3pm

100m freestyle male/female - S1 to S13

200m freestyle male/female - S14

50m butterfly male/female - S1 to S7

100m butterfly male/female - S8 to S14

150m medley male/female - SM1 to SM4

200m medley male/female - SM5 to SM14





DAY 2 – Warmup: 8 am Events starts at: 9am

50m freestyle male/female - S1 to S14

50m breaststroke male/female – SB1 to SB3

100 breaststroke male/female - SB4 to SB9 and SB11 to SB14

50m backstroke male/female - S1 to S5

100m backstroke male/female - S6 to S14

Art.8

The Swimming Events program will be done by the Swimming Coordination with every event series following WPS rules.

Art.9

Each Student Athlete will only be able to enter a maximum of 3 (three) events for the **2020 University Paralympic Games'** program.

Art.10

Each Student Athlete entry should be confirmed at the Swimming Technical Congress. If it's not possible to participate on an event for medial reasons, after confirmation, the athlete needs to check in with the Medical Delegate to be examined and, if the case, have a medical leave to the event. This document should be handed in at the call room until last call for the event. By not following this procedure, the student athlete will automatically be declassified and the IHE will lose 5 (five) points on the final score for each absence on the event, which will be identified as DNS (did not started). The Student Athlete may keep competing in following events.

Art.11

Cases not taken into consideration in this regulation, will be resolved by CPB technical board or their representative.





BOCCIA SPECIFC REGULATION

Art.1

The games will follow International Boccia Federation Updated Rules (BISFed Boccia Rules). Respecting as referral the rule in English.

Atr.2

There contests won't be separated by gender. A Student Athlete should be classified as BC1, BC2, BC3 and BC4 to be allowed an entry.

Art.3

The Student Athletes will be organized in brackets with individual contests, resolved by draw in the technical congress.

Single Paragraph: In the case of a IHE having two students of same classification that finds themselves in the same bracket after draw, there will be no changes to the bracket, unless the number of athletes from the same IHE doesn't exceed 50% of the athletes total.

Art.4

The wheelchair should ha a 66 centimeters maximum height (cushion included), except for BC3 class.

Art.5

Ramps should fit inside the area of **1** Box measuring $2,5m \times 1,0m$. Propulsion and breaking mechanisms won't be allowed.

Art.6

The Student Athlete will play with his own balls. If any kit gets disqualified by the organization, the balls are going to be replaced. If a Student Athlete do not bring his own kit, it should be communicated at the technical congress so arrangements can be done.

Art.7

Medals will be awarded to the first 3 (three) Student Athletes classified in each functional class.

Art.8

Cases not taken into consideration in this regulation, will be resolved by CPB technical board or their representative.





JUDO SPECIFIC REGULATION

Art.1

Judo competition will follow International Judo Federation rules and IBSA suggested adaptations.

Art.2

2020 university Paralympic Games' Judo competition will be open to entry for Student Athletes of both genders, with visual impairments classified und B1, B2 and B3.

Single Paragraph: To classification criteria, B1, B2 and B3 will follow IBSA norms.

Art.3

Student Athletes will compete together in classification and weight class.

Art.4

Each Student Athlete can only compete in one weight class and one absolute category.

Art.5

With the objective of promoting Paralympic Judo in university environment, during the technical congress, weight class can be grouped together depending on the number of entries.

Art.6

Student Athletes entry should follow the weight class in the table below:

Art.7

The kind of competition will follow the number of entries, as follows:

Art.8

Fight duration will be 4 minutes.

Art.9

Medals will be awarded to the first 3 (three) Student Athletes classified in each weight class.

Art.10

Cases not taken into consideration in this regulation, will be resolved by CPB technical board or their representative.





TABLE TENNIS SPECIFIC REGULATION

Art.1

Table Tennis competition will follow the International Table Tennis Federation – Paralympic Table Tennis rules and norms, and **2020 University Paralympic Games'** general regulation and Table Tennis Specific Regulations.

Art.2

Table Tennis competition will be, preferably, divided in the following classes:

- Wheelchair I to V;
- Walking VI to X;
- Intellectually impaired;

Single Paragraph: In order to be competitive, the class should have at least 3 (three) entries. In the opposite, the classes should be grouped by the Sport Technical Coordination, respecting the following criteria:

- 1. Wheelchair only;
- 2. Walking only;
- 3. Intellectually impaired only.

Art.3

Individual competitions will follow the bellow described system:

I. The individual competition will follow the dispute system presented here (1st phase in groups and following a simple eliminatory phase), the heads will be decided by the ranking of CBTM, dated at the first day of the competition month.

II. The higher scoring athlete will be placed at position number 1, second higher scoring athlete at number two, and so on. If two or more athletes have the same score, the position will be decided by a draw.

III. Every Student Athletes registered at CBTM web system will be placed following the ranking, those not registered will be placed in latter draw.

IV. Groups will be defined at technical congress, by the sport technical coordinator.

V. The Student Athletes will be allocated by the technical coordinator in groups of at least 3 (three) and a maximum of 5 (five). Playing in the next phase the 2 (two) best Athletes per group.

VI. From the 2nd phase and forward, games distribution will follow CBTM established criteria.

VII. During Qualifying phase, if two Student Athletes ends up tied, the untying decision will be based in direct confrontation.







VIII. During Qualifying phase, if three or more Student Athletes ends up tied, the untying criteria will be verified by the following formula:

Games won

Games won + Games lost

The Student-Athlete with better coefficient will be classified:

- a. If tie remains, same formula will be used for sets. The student with better coefficient will be classified.
- b. If tie remains, same formula will be used for points. The student with better coefficient will be classified.
- c. If tie remains, decision will be done by draw.
- d. The Student-Athlete that, by any reason, won't finish his game program, that means lose by WxO, in the group phase will lose effect of previous and next games, being automatically out of competition.
- e. The technical coordinator will decide if games will be disputed in first to 2 (two) or first to 3 (three) sets system, of 11 (eleven) points each set, for groups phase and eliminatory.

Art.4

Team competition will follow the system described below:

I. Technical Coordinator will state if the competition will use group system or simple eliminatory. In case of group system, the group "heads" will be decided based on CBTM rating, dated at the first day of the competition month, getting a mean score out of the sum from all team entry.

II. The higher team mean will be placed at position number one, second higher team mean at number two, and so on. If two or more athletes have the same score, the position will be decided by a draw.

III. The IHE that bring a single Male/Female Student Athlete, will be able to join a draw, during technical congress, to form teams with other Student Athletes from different IHE in the same situation.

IV. Both losing semi-finalists will be considered 3rd place.

V. Every Teams/Student Athletes registered at CBTM web system will be placed following the ranking, those Teams/Student Athletes not registered will be placed in latter draw.

VI. The game system used in the team competition will follow "Marcel Corbillon" creation: 5 (five) games shall be played, Victory will be awarded to the first team to reach 3 (three) wins. Games structure will be as follows:

1st game: A x X

2nd game: B x Y





3rd game: double game

4th game: A x Y

5th game: B x X

VII. The technical coordinator will decide if games will be disputed in first to 2 (two) or first to 3 (three) sets system, of 11 (eleven) points in each stet, groups phase and eliminatory.

Observations:

1. In the Team Category, teams with Student Athletes from different IHE will be allowed. Each Student Athlete should use their own IHE uniform. In this case, final score will be divided by the two IHE.

2. In Individual Category, each student-athlete from the same delegation won't be placed in the same group for classificatory rounds, even if their CBTM rating suggest it. In this case, the Student Athlete will be placed on the subsequent position.

3. Paddle change will not be allowed during a game, unless it comes to be damaged during the game.

4. 4 (four) to 8 (eight) blue or green colored official tables, of CBTM's recommendation brand, will be used during the competition (according to the entry number), nets and supports, as well as the balls (white, 3 stars), approved by International Table Tennis Federation.

5. Uniforms in white color will not be allowed for the Student Athletes.

Art.5

I. Double competition system will be as follows: double competition will be disputed in groups or simple eliminatory, to be decided by the Sport Technical Coordinator, the group "heads" will be decided based on CBTM rating, dated at the first day of the competition month, getting a mean score out of the sum from all team entry.

II. The higher mean will be "head" on the second bracket, the second higher mean will be "head" on the first bracket, third higher mean will be "head" on the fourth bracket, the fourth higher mean will be "head" on the third bracket. This inversion is done to invert the double confrontation, changing the doubles position at the final game.

III. If two or more athletes have the same score, the position will be decided by a draw.

IV. The IHE that bring a single Male/Female Student Athlete, will be able to join a draw, during technical congress, to form doubles with other Student Athletes from different IHE in the same situation.

V. Both losing semi-finalists will be considered 3rd place.



VI. Every Teams/Student Athletes registered at CBTM web system will be placed following the ranking, those Teams/Student Athletes not registered will be placed in latter draw.

VII. Every game will be disputed in first to 2 (two) or first to 3 (three) sets system, of 11 (eleven) points in each set.

Art. 6

Functional Classification will happen on the day before the first day of competition. To Functional Classification the Student Athlete should:

- 1. Wear evaluation suitable clothes;
- 2. Bring medical statements related to physical impairment;
- 3. Bring all game equipment: Paddle, orthosis, prothesis, crutches, wheelchairs, etc.

Art.7

Each Student Athlete should participate wearing uniforms and their own game equipment, such as wheelchair, paddle, etc.

Art. 8

The games will take place at venues and time to be determined by the Organizing Commission. There will be a tolerance of 15 minutes from the beginning of the first period schedule game. Every subsequent game will start as soon as the game before ends.

Art.9

Every game will be disputed in first to 2 (two) or first to 3 (three) sets system, of 11 (eleven) points in each set.

Art.10

A trophy for Table Tennis Efficiency will be awarded to the higher scoring Student Athlete in the sport. Medals will be awarded to the first 3 (three) Student Athletes classified in each weight class.

Art.11

Cases not taken into consideration in this regulation, will be resolved by CPB technical board or their representative.

PARABADMINTON SPECIFC REGULATION

Art.1

2020 University Paralympic Games' Parabadminton will be disputed by Confederação Brasileira de Badminton's (CBBD) General Competition Regulation, by Badminton World Federation's (BWF) official rules and by this Specific Sport Regulation.

Art.2

The following Student Athletes are eligible to Parabadminton:

1. Wheelchair class – WH (wheelchair users) – Will be offered depending on the number of entries.

WH1 – Student Athletes with physical impairment, wheelchair users, with low or moderate body control; or other reasons to not play standing up;

WH2 - Student Athletes with physical impairment, wheelchair users, with good body control; or other reasons to not play standing up;

2. Standing class – This class is offered to:

SL3 – Student Athletes with predominant lower limbs motor coordination difficulties, preventing them to play in official badminton court.

SL4 – Student Athletes with predominant lower limbs motor coordination difficulties, preventing them to move during the game in official badminton court.

SU5 – Student Athletes with predominant upper limbs disability;

SS6 – Student Athletes with short stature (Male height: up to 1,45m/ Female height: up to 1,37m).

Art.3

The Parabadminton games will be done in individual and doubles competitions.

- 1. For wheelchair doubles, depending on the entry number, pairing won't be classification nor gender restricted. In this case there will only be one wheelchair doubles category.
- 2. For standing doubles, depending on the entry number, pairing won't be classification nor gender restricted. In this case there will only be one wheelchair doubles category.
- 3. If needed, and authorized by the Student Athletes, doubles will be made by the Sport Coordination.
- 4. If the Student Athlete doesn't have a partner to assign but is willing to play in doubles and wants it to be assign by the Sport Coordination, please request during entry.







Art.4

For functional classification it will be used the official international classification

- Any functional classification change should be requested before the start of 2020 University Paralympic Games to CBBD's classification team with the exams needed.
- 2. All Student Athletes without a functional classification should bring medical report on the schedule classification date. Every medical report should be taken to the competition venue on the first day of event, so it can be reviewed by the health team.

Art.5

The competition program will be done in brackets to be established during technical congress.

Art.6

- a) Matches will be disputed in first to 2 (two) sets.
- b) Warm up won't take more than 3 minutes before each game.
- c) There should be, at least, 30 minutes between matches of the same athlete.
- d) Student Athletes can choose to reduce the resting time between matches.
- e) Teams/Athletes that leaves a game of any category or class will be disqualified and considered forfeiting, being disqualified from the competition.

It will be considered renouncing:

- 1) Do not show in time for the game;
- 2) Give up at any time from the competition;
- 3) Be present, and in time, for the game, but decides not to play.

Art.7

If there's need of team change, it should be communicated during the technical congress. During the competition, team change will not be allowed, unless in case of injury. In this case, the Student Athlete coming in, should have a valid **2020 University Paralympic Games'** entry.

Art.8

Categories:

- a) Male Individual (SM)
- b) Female Individual (SF)
- c) Doubles (Male, Female and Mixed)

Obs: Entered Student Athletes will be allowed to play in 2 (two) categories.

Single Paragraph: In case of not enough entries to fill groups, followed by brackets, a single group format will be done.

Art.9

Wear the IHE uniform is mandatory. 75% of the visible area of each piece (tshirt or shorts) should be of the same color. It is not mandatory to wear the Student Athlete name on the t-shirt, but at the same time it is forbidden to wear other Student Athlete names, or position, on their t-shirts. Wearing cargo shorts or hats, although bandanas and headbands are allowed. During award's ceremony, Student Athletes should not be waring flipflops.

Art.10

Medals will be awarded to the first 3 (three) Student Athletes classified in each weight class.

Art.11

Cases not taken into consideration in this regulation, will be resolved by CPB technical board or their representative.





Any situation not taken into consideration in this regulation will be resolved following official IWBF's Wheelchair Basketball 3x3.

Art.1 COURT

Matches will take place in official basketball half-court. The court should have regular basketball measurements ($15m \times 11m$), including free throw line (5.80m), 3 points line (6.75m), and no "no charge" marking under the net.

Art.2 TEAMS

Each team can entry a maximum of 5 (five) players, of those 3 (three) in play and 2 (two) substitutes, and 1 (one) coach. **Only one team for each State is allowed.**

Art.3 GAME OFFICIATING

The game will be officiated by 2 (two) officials and 3 (three) table officials.

Art.4 BEGINNING OF THE GAME

4.1 Both teams will warm up simultaneously at the same half-court before the game, for 7 minutes.

4.2 Coin toss will determine the first possession. After, the official will follow the alternating possession procedure for every beginning of quarter or held ball situation.

4.3 The game cannot begin if one of the teams is not on the court ready to play with 3 (three) players. In the case the team is not ready to play, will lose the game for forfeit.

Art.5 GOAL AND IT VALUE

5.1 Every successful throw made inside the 6.75m count 1 (one) point.

5.2 Every successful throw made outside the 6.75m count 2 (two) points.

5.3 Every free throw will count 1 (one) point.

Art.6 GAME CLOCK

6.1 The game shall consist in 2 (two) periods of 5 (five) minutes each, with 30 seconds between the two. The game clock will only stop at free throws situations, and will start right after the last free throw, converted or missed.

6.2 The first team to score 17 (seventeen) points will be declared winner. This rule will only prevail for normal game time, been disregarded during overtime.

6.3 If the game time ends with a tie, teams will play into overtime. There shall be an interval of 1 minute between the end of regulation and overtime. The first team to score a field goal will be declared winner.

6.4 The ball possession to begin the overtime will follow alternating possession rule.

6.5 A team shall lose the by forfeit, if not present or unable to field 3 players ready to play at the scheduled game time.

Art.7 FREETHROWS

7.1 After a team has committed 7 collective fouls (they will count for both periods), every following foul will be penalized with free throw.

7.2 If a player commits 4 (four) player personal foul will be excluded from the game.

7.3 If a foul is committed during the act of shooting inside the 1-point area, it will be penalized with 1 free throw.

7.4 If a foul is committed during the act of shooting inside the 2-point area, it will be penalized with 2 free throws.

7.5 If a foul is committed during the act of shooting and the throw is successful, it will count and gain 1 free throw in addition.

Art.8 SHOT CLOCK

Both teams will have 14 seconds of ball possession, following the same criteria of the Wheelchair Basketball Shot Clock rule.

Art.9 GAMEPLAY

9.1 After a successful throw or free throw, the opposite team shall dribble or pass the ball, from inside the court, to the outside of the 6.75 meters line, from where the team will be able to try the goal. After a successful throw, the team shall not defend from under the net.

9.2 The same situation is valid if there's change of possession after rebound.

9.3 A player is considered behind the 6.75 meters line when all wheels are out of the line. The line itself is considered inside of the arch.

9.4 The ball is considered as being thrown to inside the 6.75m line **when:**

- The ball leaves the player hand(s), as pass or throw, from behind the 6.75m line, OR
- The player with ball possession is outside the 6.75m line and one of his wheels touches the line or the floor inside the line, OR
- The ball touches the line or the floor inside the line.

Art.10 SUBSTITUTIONS

Substitutions will be allowed for both teams in dead ball situations.

Art.11 TIMOUTS

Both teams shall ask for 1 (one) 30 (thirty) seconds timeout during the whole game, including overtime.

Art.12 FUNCTIONAL CLASSIFICATION

By any means a team shall be over the 9-point limit rule. In case a player comes into the game and the team exceeds the 9-point rules, 1 score point will be awarded to the opposing team.

Art.13 GAME BALL

The game ball will be the official male adult 3x3 basketball.

Art.14 AWARDS

Trophies will be awarded to the 3 (three) higher ranked Teams, as well as medals to all Student Athletes and coaches of those teams. A separated trophy will be awarded to the score champion.

Art.11 CASES NOT TAKEN INTO CONSIDERATION

Cases not taken into consideration in this regulation, will be resolved by CPB technical board or their representative.
